


## 1. Introduction

The State Government is empowered to declare that all or any of the provisions of the Act shall apply to any place wherein manufacturing process carried out irrespective of number of workers employed therein. Madhya Pradesh Government has made this act applicable to stone crushers, slate pencil factory, Rice mill, Oil mill, saw mills, chuna bhatti, Factories using asbestos ,certain industries which use hazardous chemicals, and certain processes carried out using flammable solvents by publishing a notification, even if the number of workers employed therein are less than 10. Occupier is not allowed to use any of these premises as a 'factory' unless he has obtained a valid factory licence.


